

The regular meeting of the City Council was held in the Municipal Court Room on February 15, 1972 at 7:30 P.M. with Mayor Flanary presiding.

Present: V.O. Flanary, Robert Leonard, Ike Fultz, Archie Woods

Also Present: Milas D. Franks, City Manager

Minutes of the previous meeting were read and approved.

On motion by Ike Fultz, seconded by Archie Woods and carried by unanimous vote the following resolution regarding C.W. Bryant, expired, was passed: (Page 89) 5934

Mayor Flanary read resignation of W.F. McElroy as member of City of Norton Electoral Board and resignation for City of Norton Redevelopment & Housing Authority. 5935

Vice Mayor Leonard stated that due to the untimely death of Councilman Bryant, council would now consider appointment of new member.

On motion by Robert Leonard, seconded by Archie Woods and carried by unanimous vote council moved that W.F. "Dude" McElroy be appointed to serve the unexpired term of C.W. Bryant, expired. 5936

The Clerk administered the Oath of Office to Mr. McElroy after which he took his seat as councilman. 5937

Mr. Wright Dawson congratulated council for their fine selection in choosing a councilman. 5938

Mr. Franks presented recommended changes in Garbage Collection rates. Council discussed this matter briefly. 5939

On motion by Robert Leonard, seconded by Archie Woods and carried by unanimous vote council moved that the following ordinance be adopted as provided for in 14-27 (d) of the Code, regulating garbage collection fees for commercial users. (Page 89)

On motion by Robert Leonard, seconded by Ike Fultz and carried by unanimous vote council moved that the following ordinance reenacting Section 14-27 (e) be passed: Page 89) 5940

Mr. Franks advised council he was unable to make recommendation for an appointment to City Planning Commission at this time. Matter deferred until next council meeting. 5941

Mr. Franks advised council of the new employees through Lenowisco. 5943

On motion by Ike Fultz, seconded by Archie Woods and carried by unanimous vote Harold Hagy was reappointed as member of Norton Redevelopment & Housing Authority for four year term, retroactive to Jan. 28, 1972. 5944

On motion by Ike Fultz, seconded by Archie Woods and carried by unanimous vote council moved that John Harman be reappointed as member of Housing Appeals Board, for five year period beginning Feb. 18, 1972. 5945

Mr. Franks advised council of League Convention to be held in Richmond, October 1,2,3 1972. 5946

The city manager advised council that 9th grade class would like to reschedule their program on drugs for council meeting March 7, 1972. 5947

Mr. Franks advised he had contacted the different city boards asking for recommendation for persons to serve on annexation committee. He advised that N.I.D.A. had recommended Charles Litton and that Housing Authority had recommended Wright Dawson. Council deferred action on appointments until further study could be made. 5948




