

The regular meeting of the City Council was held in the Municipal Council Chambers on May 17, 1988 at 7:30 P.M. with Mayor Daniels presiding.

Invocation was given by Father Joe D! Aurora followed with Pledge of Allegiance led by Sam Mongle. 14129

On motion by Jack Wallace, seconded by Robert Raines and carried by unanimous vote, Council moved that minutes of May 3, 1988 be approved with correction to Paragraph 14122 by adding word (Insert). 14130

The Mayor announced he had an item from Commissioner of Revenue to be inserted in agenda and that this item would be 1A. 14131

The Mayor announced he had a letter from Mr. Marcum, Commissioner of Revenue, requesting a refund in amount of \$209.05 for personal property that was erroneously assessed for the tax year 1987.

On motion by Jack Wallace, seconded by Robert Raines and carried by unanimous vote, Council moved they go back into regular session.

The Mayor declared council back in regular session.

Robert Raines nominated Mr. Ron McCall & Mr. Bruce Shifflett to City of Norton School Board for a three year term, said term to expire 6-30-91. 14140

On motion by Jack Wallace, seconded by Roy Roberts and carried by unanimous vote, Council moved nominations cease.

The Mayor declared Ron McCall and Bruce Shifflett reappointed as members of City of Norton School Board for a three year term, said term to expire 6-30-91.
