Larry Gannaway, as spokesman for a group of citizens from Sentury
Trailer Court, appeared before Council expressing their concern that TV
Cable Service had been denied to them because of an alleged unsettled contract agreement between the owners of the mobile home park and TV Cable
Service. Council discussed this matter with the citizens present and with
Mr. Morgan Russell of TV Cable Service. Council advised that in it's opinion,
TV Cable Service should not be denied to the residents of the mobile home
park because of the alleged contract dispute between the mobile home park
owner and the TV Cable company. Council encouraged Mr. Russell to provide
cable service to the residents in question.

Enterprises, Inc. to give financial support for the continuation of this service to the community. After considerable discussion by the Council with Morgan Russell and all others present, the Mayor called for the reading, in it's entirately, of the ordinance granting to P.G.R. Enterprises, Inc. an exclusive franchise to operate a community antenna television system for the City of Norton.

Enterprises, Inc. an exclusive franchise to operate a community antenna television system for the City of Norton, including the amended cover letter of March 2, 1976, attached to and made a part of the ordinance and including the amended schedule of rates attached to and made a part of the ordinance, with second reading of ordinance scheduled for

next regular Council meeting.

On motion by George Hunnicutt, seconded by Jim Humphreys and carried by unanimous roll call vote; George Hunnicutt, yes; Ike Fulks, yes; Roy Roberts, yes; Jim Humphreys, yes, Council moved that Glenn Jones be appointed as member of Norton Industrial Development Authority to fill the unexpired term of W. P. Kanto, resigned, said term, which is to expire January 1, 1979.

Discussion of location of new Health Department Building was tabled until a report could be received from Mr. Holyfield, Administrator of Wise County Health Department.

City Manager advised Council that the School Board had requested joint budget work sessions for March 15, 1976 at 7:00 P.M. Council was in agreement with this date.
