

The regular meeting of the City Council was held in the Municipal Council Chambers on February 7, 1989 at 7:30 P.M. with Mayor Daniels presiding.

Invocation was given by Rev. Bill Watson, followed with Pledge of Allegiance led by Bill Stokes.

On motion by Robert Raines, seconded by Roy Roberts and carried by unanimous vote, Council moved that minutes of January 17, 1989 be approved as presented.

Audience for Visitors - No response.

Request for permission to install a facade over City Right of Way by Mr. W.P. Armistead. The City Manager addressed this subject. Vice Mayor Raines spoke briefly on this subject.

On motion by Roy Roberts, seconded by Jack Wallace and carried by unanimous vote, Council moved that a revocable license be issued to W.P. Armistead to install an overhang over City Right of Way.

Request for permission to install a facade over City right-of-way by Ace Advertising. City Manager Ward addressed this subject. Council briefly discussed this matter. Council agreed for this matter to be advertised in Coalfield Progress for Public Hearing on February 21st so that an input from citizens could be heard.

Renewal of the Bingo and Raffle Permit, and Waiver of Permit Fee, for the Norton City Schools.

On motion by William Mays, seconded by Roy Roberts and carried by unanimous vote, Council moved for the renewal of the bingo and raffle permit and Waiver of Permit fee for the Norton City Schools.

Discussion of proposed changes to the Motor Vehicle License Ordinance. The City Manager addressed this subject pointing out reason for each change in the ordinance. Council briefly discussed this matter. Council agreed to have the changes in this ordinance advertised for March 7th public hearing.
