

The regular meeting of the Norton City Council was held in the Municipal Council Chambers on April 21, 1987 at 7:30 p.m. with Mayor Cliff Daniels presiding.

Present: Roy Roberts, Jack Wallace, Cliff Daniels, Robert Raines, and William Mays

Also Present: C. R. Brown, City Manager and Kenneth Asbury, City Attorney

The invocation was given by Father Joseph D'Aurora followed by the Pledge of Allegiance which was led by Mayor Daniels. 13784

On a motion by Roy Roberts, seconded by Jack Wallace, and passed by unanimous vote, Council moved that the minutes of the April 7, 1987 meeting be approved as presented. 13785

There was no response to the Mayor's call for visitors. 13786

The City Manager asked Council for the authority to transfer funds in the amount of \$2500 from Contingency, Account Number 9110-00-5804, to the Assessor, Account Number 1210-3003, to cover May and June 1987 expenses.

Upon a motion by Roy Roberts, seconded by Robert Raines, and passed by unanimous roll call vote, Council authorized the City Manager to transfer funds in the amount of \$2500 from Contingency, Account Number 9110-00-5804, to the Assessor, Account Number 1210-3003, to cover May and June 1987 expenses. 13787

The City Manager read a Resolution of the City Council of the City of Norton, Virginia Declaring April 24 Through May 4, 1987 as Keep America Beautiful Week in Norton.

Shelly Knox, Parks and Recreation Director, advised Council of the activities planned for this ten day period. The City is again sponsoring the Adopt-A-Truck Program; Saturday, April 24th is Clean Up Day; and Wednesday, April 28th is Pat-On-Back Day for City Employees. 13788

Upon a motion by Jack Wallace, seconded by William Mays, and carried by unanimous vote, Council passed a Resolution of the City Council of the City of Norton, Virginia Declaring April 24 Through May 4, 1987 as Keep America Beautiful Week in Norton. (Insert)

There was a brief discussion on the proposed Ordinance to Require Removal, Repair, or Secure of Any Building, Wall or Other Structure Which Might Endanger the Public Health or Safety of Residents.

The City Manager advised that the Planning Commission had reviewed this ordinance with no public hearing held and recommended that this proposed ordinance be brought to Council. 13789

The City Attorney advised that the City needed to pass this proposed ordinance and that both he and the City Manager recommend its passage.

The Mayor advised the City Manager that it was Council's consensus to advertise a public hearing for this proposed ordinance.

The Mayor advised that under Executive Session - Legal we were expecting some people in attendance later this evening. In view of this, Council changed the agenda and went on to the City Manager's comments. 13790

The Manager had no comments at this time. 13791

Mayor Daniels advised that the City had received a check in the amount of \$3500 from the Kline Foundation as a donation to the new City park. 13792

Upon a motion by Jack Wallace, seconded by William Mays, and passed by unanimous vote, Council moved to recess the Council Meeting approximately 30-45 minutes. 13793
During this recess, Council proceeded with the work session for the 1987-1988 budget.

Upon a motion by Jack Wallace, seconded by William Mays, and passed by unanimous vote, Council moved to go back into regular session.

Upon a motion by Robert Raines, seconded by Jack Wallace, and passed by unanimous vote, Council moved to go into Executive Session to discuss personnel matters as per 2.1-344 (A) (1) of the Code of Virginia, as Amended and Legal Matters as per 2.1-344 (A) (6) of the Code of Virginia As Amended.

Upon a motion by Roy Roberts, seconded by Jack Wallace, and carried by unanimous vote, Council moved to go back into regular session.

The Mayor advised there was nothing to report pertaining to legal matters.

Mayor Daniels announced the floor was open to nominations for the Norton Industrial Development Authority.

Roy Roberts nominated Dorothy Chittester and Wally Witt for reappointment to the Norton Industrial Development Authority. Robert Raines motioned that nominations cease. This was seconded by William Mays and carried by unanimous vote that Dorothy Chittester and Wally Witt be reappointed for four year terms to the Norton Industrial Development Authority with said terms expiring May 10, 1991.

The Mayor announced the floor was open for nominations to the Regional Sewer Authority.

William Mays nominated Ron McCall for reappointment. On motion by Jack Wallace, seconded by Robert Raines, and carried by unanimous vote, Council moved that the nominations be closed.



The Mayor advised the appointments to the Department of Social Services are being tabled until the next meeting.


