

The regular meeting of the City Council was held in the Council Chambers on October 7, 1986 at 7:30 P.M. with Mayor Daniels presiding.

Present: Robert Raines, Cliff Daniels, Williams Mays

Absent: Roy Roberts and Milas Franks

Also Present: C.R. Brown, City Manager & Kenneth Asbury, Attorney

Invocation was given by the Rev. Donald Bowles, followed with Pledge of Allegiance led by Otis Mullins, Jr. 13592

On motion by William Mays, seconded by Robert Raines and carried by unanimous vote, Council moved that minutes of Sept. 16, 1986 be approved as presented. 13593

The Mayor announced audience for visitors.

Michael Taylor, 102 Ky. Ave., spoke in behalf of the car wash from water coming out of the mountain. He was asking permission to wash cars down on City property but with same mountain water. The City Manager addressed this subject stating the governing body was the only one to grant this permission for use of City property. Council briefly discussed this matter with Mr. Taylor and others present regarding this matter. The Mayor advised that this meeting was to be continued until Monday at 7:00 P.M. at which time this would be the first thing on the agenda. 13594

Ray Peters of 415 Virginia Avenue, N.E. appeared before council and presented problem which he is having at his residence. First, he would like to know how a person could get a dog Kennel license without first being checked out by the health people for the sanitary conditions. Mr. Peters addressed this subject at length pointing out the unsanitary condition this kennel presents. Council discussed this matter briefly with Mr. Peters and the City Manager hopes to have an answer to this matter by Monday, October 13th meeting. 13595

Birdell Ballenger appeared before council in regard to his request of last council meeting. He also complained of rats and lights in that section of southside of Norton. After a brief discussion, this matter is to be brought up again at the continued meeting on October 13th. 13596

The Mayor announced that Item C & Item F would not be discussed tonight but would be on agenda in continued session on Monday, October 13th. 13597

Confirmation of a check, in the amount of \$145,000, to the Norton City School. On motion by Robert Raines, seconded by William Mays and carried by unanimous roll call vote, Council moved that confirm check in the amount of \$145,000 to City of Norton School Fund. 13598

Discussion of Conflict of interest as pertains to voting on Norton School Board appointments and appropriations.

Mr. Asbury, the City Attorney, addressed this subject stating Mr. Mays could not vote on additional appropriations or appointments to School Board due to conflict of interest but that Robert Raines would have no conflict in this matter. Council will have four eligible voting members on appropriations and appointments to School Board. 13599

Discussion of water reserves and progress to date. Mr. Brown addressed this subject, stating that at 2:30 P.M. of this day we had 40.6 million gallons of 13600 water.

Request to pay Ocean Services for repairs to Lower Dam and Inspection of upper dam intake.

Mr. Brown brought council up-to-date on this matter.

On motion by Robert Raines, seconded by William Mays and carried by unanimous roll call vote, Council moved that pay to Ocean Services the sum of \$32,128.78 for repairs to Lower dam and inspection of upper dam intake, from the Water 13601 Fund.


Comments by the City Manager - The City Manager advised of ARC Grant in amount of \$250,000 to lay necessary water lines from Esserville to Ramsey and to put a tank in Esserville section. Mr. Brown discussed with council the things in the making for the water system. 13602

The Mayor announced the intent of continuing this meeting was the discussion of high pressure sodium vapor lights and possible executive session for appointments. We will then go into work session on water. The main plus of the conversation is to discuss the potential water sources. 13603
