

The regular meeting of the City Council was held in the Council Chambers on December 2, 1986 at 7:30 P.M. with Mayor Daniels presiding.

Present: Roy Roberts, Robert Raines, Cliff Daniels, Milas Franks, William Mays

Also Present: C.R. Brown, City Manager & Kenneth Asbury, Attorney

The Invocation was given by the Rev. Bill Watson, followed with Pledge of Allegiance led by Councilman Roberts. 13658

Mayor announced there would be a change in agenda under Executive Session to include legal matters. 13659

On motion by Roy Roberts, seconded by Robert Raines and carried by unanimous vote, Council moved that minutes of special called meeting of November 17th be approved as presented. 13660

Amend the minutes of Nov. 18th #13650 in line three add between words project plan the word "capital" and in next line change word for to thru.

On motion by Milas Franks, seconded by William Mays and carried by unanimous vote, Council moved that minutes of Nov. 18, 1986 be approved as amended. 13661

Jerry Sturgill appeared before council with further reference to sign on his property at the Lone Star Service Station. Mr. Brown addressed this subject and advised he would like to go on record of not thinking we should allow the sign. Mr. Sturgill advised council he had been before the Planning Commission as instructed by Council and they had approved recommendation for this sign to Council. The City Attorney also addressed this subject. Council discussed this matter at length. The Mayor advised council would make the decision at the Dec. 16th meeting as to whether they were going to advertise for public hearing on this sign request. Council is to receive a copy of minutes of the Planning Commission. 13662

Council briefly discussed water reserves. Mr. Brown advised that as of this morning at 10:15 we had 92.4 million gallons of water in the reservoirs. Council briefly discussed this reserve. 13663

Discussion of House Bill 311 Requiring Fire Suppression System in Buildings 50 feet or higher. Council discussed this matter briefly. No definite action taken at this time. 13664

On motion by Robert Raines, seconded by Roy Roberts and carried by unanimous vote, Council moved they go into executive session to discuss legal matters as Per 2.1-344 (A) (6) of the Code of Virginia, As Amended and Personnel as Per 2.1-344 (A) (1) of the Code of Virginia, As Amended. 13665

On motion by Roy Roberts, seconded by Milas Franks and carried by unanimous vote, Council moved they go back into regular session. 13666

The Mayor declared council back in regular session.

The Mayor announced appointments will be postponed until January. Under legal we have not proceeded far enough to make any report at this time.

Comments by the City Manager - 1. A reminder of the City's Christmas Party on the 11th of December at 7:00 P.M.

2. Tentatively at this time the closing of the Farmer's Home Loan is scheduled for Dec. 19th - It might be on the 18th. 3. Would like council's

guideline in allowing my office to set the holiday hours since Christmas this year comes on Thursday. Mr. Franks suggests allow the City Manager to set a schedule for this year. Roy Roberts concurred with this suggestion.

4. Planning Commission has been very effective. On the 11th of this month two public hearings are scheduled - Flood Plain Ordinance and Off-Street Parking. Council briefly discussed this matter.
