Cliff Daniels nominated Joe Sinicrope for reappointment to Housing Appeals Board for a five year term, said term to expire Feb. 18, 1990.


On motion by Ray Salyers, seconded by Roy Roberts and carried by unanimous vote, Council moved nominations be closed. 13113
