

The regular meeting of the City Council was held in the Municipal Court Room on June 4, 1985 at 7:30 P.M. with Mayor Hunnicutt presiding.

Invocation was given by Dr. Parrish Jones.

On motion by Milas Franks, seconded by Ray Salyers and carried by unanimous vote, Council moved that minutes of May 21, 1985 be approved as presented. 13199

Public Hearing on "An Ordinance Adopting the Motor Vehicle Code as Amended and the Code of Virginia as Amended on Driving a Motor Vehicle while intoxicated.

No comment from the audience.

On motion by Milas Franks, seconded by Ray Salyers and carried by unanimous vote, Council moved that "An Ordinance Adopting the Motor Vehicle Code as Amended and the Code of Virginia as Amended on Driving a Motor Vehicle while intoxicated" be passed on first reading. 13200

On motion by Milas Franks, seconded by Cliff Daniels and carried by unanimous roll call vote, Council moved that refund, from Revenue \$22.11 to Salvatore A. Odierne, for Overpayment of Taxes. 13204

Proposed use of Coal Haul Road Tax Funds within the City of Norton for 1985-1986.

Mayor Hunnicutt reported on Coal Haul Road Committee, of which he is a member, and presented their recommendations to council.

"On motion by Jim Hincer, seconded by Gary Bowers and carried by Unanimous vote, Coal Haul Road Committee recommended to the City Council tht such improvements as patching shoulders, drainage, paving and signs be provided on 610, 620, 58, 74 and then 23 with funds in Coal Haul Road of \$23,870, thru May, plus June collections." The committee ask that council give favorable consideration to this recommendation.

On motion by Cliff Daniels, seconded by Milas Franks and carried by unanimous roll call vote, Council moved that accept recommendation of the Coal Haul Road Committee as presented and that sum of \$23,870, plus June collections be expended in manner set forth. 13205

Request for a sewer connection in the County, Mr. William Shepherd, recommended by the Planning Commission.

Request for a sewer connection, in the county, Mr. Mike Owens, recommended by the Planning Commission. 13206

On motion by Milas Franks, seconded by Cliff Daniels and carried by the following votes, Salyers, Hunnicutt, Franks, Daniels, YES; Roberts, No, Council moved that sewer connections be granted William Shepherd and Mike Owens, in the County. 13207

Confirmation of Street name in Norton Heights, Alexander Circle, as recommended by the Planning Commission.

On motion by Roy Roberts, seconded by Ray Salyers and carried by unanimous vote, Council moved that accept recommendation of Planning Commission for the street name in Norton Heights to be Alexander Circle. 13208

On motion by Cliff Daniels, seconded by Milas Franks and carried by unanimous vote, Council moved that go into Executive session to discuss personnel as per 2.1-344 (A) (1) of the Code of Virginia, as Amended and Legal Matters as per 2.1-344 (A) (6) of the Code of Virginia, as Amended. 13209

On motion by Cliff Daniels, seconded by Milas Franks and carried by unanimous vote, Council moved they go back into regular session.

The Mayor declared council back in regular session.

On motion by Cliff Daniels, seconded by Milas Franks and carried by unanimous roll call vote, Council moved that upon the recommendation of the City Attorney the City Administration be authorized to refund from revenue, business license as in provision of law. 13210

No action on appointment to Norton Redevelopment & Housing Authority.

Milas Franks nominated Pedie Poston for recommendation to Judge of Circuit Court for appointment on Board of Zoning Appeals.

On motion by Cliff Daniels, seconded by Roy Roberts and carried by unanimous vote, Council moved the nominations be closed.

The Mayor declared Pedie Poston nominated for appointment to Board of Zoning Appeals by Judge of Circuit Court for five year term.

Roy Roberts nominated Ron McCall for reappointment to City of Norton School Board and Bruce Shiflett appointed to City of Norton School Board.

On motion by Cliff Daniels, seconded by Milas Franks and carried by unanimous vote, Council moved the nominations be closed.

The Mayor declared Ron McCall and Bruce Shiflett appointed to City of Norton School Board for three year term, said term to expire June 30, 1988.

Cliff Daniels nominated Mrs. Bruce Fraley for reappointment to Wise County Regional Library Board. 13211


On motion by Milas Franks, seconded by Roy Roberts and carried by unanimous vote, Council moved the nominations be closed.


The Mayor declared Mrs. Bruce Fraley reappointed to Wise County Regional Library Board for four year term, said term to expire 6-30-89.
