

The regular meeting of the City Council was held in the Municipal Court Room on December 2, 1980 at 7:30 P.M. with Mayor Hunnicutt presiding.

Also Present: G.M. Newman, City Manager

On motion by Cliff Daniels, seconded by Robert Collier and carried by unanimous vote, council moved that minutes be approved as presented.

Mr. Leslie Mullins appeared before with reference to completion of U.S. 23 and U.S. 58 in this area. Mr. Mullins discussed this matter at length with Council.

On motion by Cliff Daniels, seconded by Robert Collier and carried by unanimous vote, council moved that propose a very early January meeting for purpose of encouraging our legislators to go to bat for us in the further development of U.S. 23 & U.S. 58 in this immediate vicinity, motion further stipulates that a formal resolution be prepared to present to our representatives.

Mr. Jess Brickey of 199 7th St. N.E. (Pennyroyal) was present requesting that something be done regarding road where big heavy trucks had broke the sides of road in, causing water to run down over this property. He stated this was ruining his property. Council referred this matter to City Manager to see what could be done.

Mr. Jim Price of Bernice Avenue up above Hamner Avenue was present inquiring of the status of water pressure to that section of the city. The City Manager discussed with council and Mr. Price just what progress had been made on this line. He advised that there had been some difficulty in getting some of the easements. Council directed the City Manager to get the city attorney to push the matter of easements for property. Referred to city manager for follow up.

Consideration of contract for preliminary engineering T. & L. Mr. Ed Phillips presented supplemental agreement, presenting different changes in the original agreement. Council discussed this matter briefly with Mr. Phillips and Mr. Litton. Mr. Phillips discussed at length Clear Creek water situation. Mr. Phillips advised council that he would like to meet with them to go over the alternatives.

The City Manager presented for consideration adjustment of water rates for P.S.A. Council discussed this matter at length. The City Manager was directed to check further into this matter and report back to council at next meeting.

On motion by Robert Collier, seconded by W.F. McElroy and carried by unanimous vote, council moved that go into executive session to discuss personnel matter.

On motion by Robert Collier, seconded by W.F. McElroy and carried by unanimous vote, council moved they go back into regular session.

Mayor Hunnicutt advised there was no definite conclusion to this whatever.

9998


Councilman Jones spoke briefly on resignation of Chief Earle Brown.


