

The regular meeting of the City Council was held in the Municipal Court Room on October 2, 1979, at 7:30 p.m. with Mayor Hunnicutt presiding.

Present: George Hunnicutt, W. F. McElroy, Robert Collier, Cliff Daniels, Frank Fischer

On motion by Cliff Daniels, seconded by Frank Fischer, and carried by unanimous vote, Council moved that the minutes be approved as written.

On motion by W. F. McElroy, seconded by Cliff Daniels, and carried by unanimous vote, Council moved that the General Waterline Specifications be adopted as submitted and that they be submitted to Health Department for their approval. (Insert)

Gary Roberts appeared before Council regarding "Accessibility for the Handicapped" to load and unload on streets. Also restrooms. He asked Council if they were willing to get involved. No definite action taken.

Mr. Hoyt Williams, of Thompson and Litton, was present and presented request for supplemental charge, EPA Study. Council discussed this matter with Mr. Williams and directed the City Manager to take the matter up with the County and Town of Wise with regard to participation in payment for this study. Matter tabled until the City Manager has talked with the other two entities involved.

Mr. Newman advised Council that the City had been selected as one of the twenty one finalist cities to appear before the All-American Cities Award Jury during the 85th National Conference on Government. Council discussed this matter briefly with Mr. Newman.

On motion by Cliff Daniels, seconded by Robert Collier, and carried by unanimous roll call vote, Council moved that they accept the finalist position for All-American cities and pursue the application with an expenditure not to exceed \$3,000.00.

On motion by W. F. McElroy, seconded by Frank Fischer, and carried by unanimous vote, Council moved that the following fire department officers be accepted. (Insert)

On motion by W. F. McElroy, seconded by Cliff Daniels, and carried by unanimous vote, Council moved that they authorize the City Manager to submit preapplication for the 1.5 million dollar Community Development Multiyear's Comprehensive Grant.

Council briefly discussed option for Community Hospital property. Council directed the City Attorney to make necessary changes in option as presented and bring back to next meeting for passage.

The City Manager ask that Council consider a service charge on returned checks. On motion by Robert Collier, seconded by Frank Fischer, and carried by the following votes, McElroy, Collier, Daniels, Fischer, YES; Hunnicutt, NO, Council moved that City Manager be authorized and directed to charge \$5.00 for insufficient fund checks returned.

Mrs. Lola Ford was present and inquired as to times she would be able to discuss her reassessment. Council discussed this matter at length and directed the City Manager to take the matter up with Board of Assessors and find out just when they will be able to hear every citizen other than two days set for hearings.

There being no further business to come before the Council, same adjourned.
